Introduction:

Berkhamsted Gymnastics Club (BGC) recognises that all children and young people have a right to protection and that the welfare of children, young people and vulnerable adults is paramount. BGC acknowledges their duty of care to safeguard and promote the health, safety and welfare of children, young people and vulnerable adults by ensuring safeguarding practice reflects and complies with best practice and **British Gymnastics (BG)** policies (which are updated regularly based on changes to legislation).

Berkhamsted Gymnastics Club commits to:

- Adopting the British Gymnastics health, safety and welfare guidelines <https://www.british-gymnastics.org/safeguarding-and-compliance-policies>
- Ensuring staff and volunteers understand their roles and responsibilities in respect of safeguarding and are provided with appropriate learning opportunities to recognise, identify and respond to signs of abuse, neglect and other safeguarding concerns relating to children and young people.
- Appointing a Welfare Officer to whom grievances or concerns can be made confidentially in person, via welfare@berkhamstedgymnastics.co.uk or by calling 07947 396 630

- Encouraging an open environment where gymnasts, staff, volunteers and parents can raise any concerns without fear of negative repercussions.
- Ensuring that any grievances or concerns are dealt with promptly and in accordance with the **BGC Grievance and Complaints Procedure**
- Ensuring appropriate action is taken in the event of incidents/concerns of abuse and support will be provided to the individual/s who raise or disclose the concern. For more information refer to: **BGC Reporting Welfare Concerns**
